## **Our Mission Statement:**

**Our mission is to help get sons & daughters home safe on weekends, with their vehicles.**

1. There **must be** minimally **three Designated Driver Dads** working together at all times. Two **Designated Driver Dads** drive the patron(s) home with the patron(s) in the back seat like taxis do. The other **Designated Driver Dad** follows behind in their vehicle.
2. **Designated Driver Dads** are **not** allowed to drive within 24 hours of drinking alcohol.
3. **Designated Driver Dads** must **not** do any illegal drugs at any time.
4. **Designated Driver Dads** must have a valid driver's license within that province before operating any patrons vehicle.
5. There are no mandatory schedules for **Designated Driver Dads** as this is strictly volunteer work.
6. **Designated Driver Dads** are to initially make contact with the nightclubs or bars within the city that they are operating out of. **Designated Driver Dads** posters are given to the doorman at each nightclub or bar. It is up to each establishment as to where the **Designated Driver Dads** service is to be advertised. (We suggest a poster in each washroom and at all exit doorways.)
7. **Designated Driver Dads** drive to a nightclub, bar, or event of their choice on a Friday or Saturday night between the hours of 1:00 am & 3:00 am. Contact with the doorman is made first. The **Designated Driver Dad** gives the doorman a business card with their cellular phone number written on the back. The **Designated Driver Dads** are to stay away from all taxi zones. Do not park in front of the bars, or nightclubs. **Designated Driver Dads** don't go into the bars or nightclubs. (Referral from the doorman is essential.)
8. **Designated Driver Dads** are to let the doorman, event organizer, or police, know that their service is available, each time they arrive or return to the nightclub, bar, or event. It is up to the doorman, or organizer to give the business card to anyone that they may view as potentially over the legal drinking limit. The business card acts like a "**ticket**" & is given back to the **Designated Driver Dads** upon receiving the service. **Designated Driver Dads** simply wait for calls outside, or by those they meet outside.
9. **Both Designated Driver Dads** must verify that the patron's vehicle has proper insurance coverage with current, valid, third party liability, before they agree to drive the patron(s) vehicle home for them.
10. **Two Designated Driver Dads** drive the patron(s) home in the patron's vehicle with the other **Designated Driver Dad** following behind, in their own vehicle that they arrived in. The patron(s) must be driven home in the vehicle they came to the bar, or nightclub, in the back seat, with the two **Designated Driver Dads** operating the patron's insured vehicle in the front seats. Verbal permission to operate the patron(s) vehicle must be witnessed by all three **Designated Driver Dads** prior to driving the patron(s) home.
11. Each **Designated Driver Dad** assumes all responsibility for any deductible payable under the patron's vehicles insurance collision coverage. If an accident occurs while operated by the **Designated Driver Dad**, then the insurance deductible is to be paid by the **Designated Driver Dad** that was driving, if the patron(s) refuses to cover the insurance deductible.
12. If the patron(s) vehicle is not properly insured then the **Designated Driver Dads** do not have to drive the patron(s) home. The patron(s) is first responsible to take a taxi home, as the service is designed to get patron(s) and their vehicles home safe primarily. The secondary option of just driving the patron(s) home is at the discretion of the three **Designated Driver Dads**.
13. **Canadian Designated Driver Dads Inc.** is a concept that can be reproduced in any Canadian community, if approval from **Canadian Designated Driver Dads Inc.** is received prior to using the corporate name, corporate logo, business cards, posters or T-shirts. (PDFs of the corporate artwork is available upon request, if the individual qualifies and agrees to all the terms listed.)
14. Approval in writing from **Canadian Designated Driver Dads Inc.** must be applied for and secured prior to operating or using the corporate name, or corporate logo of **Canadian Designated Driver Dads Inc.**
15. All three of **Designated Driver Dads** can decide for themselves how the money received can be donated, once their own gasoline expenses are covered. The cost of getting a drivers abstract, & a criminal record check, or printing business cards, posters & T-shirts to get operational may be a part of the expenses recovered by donation. (We suggest donating the rest to **M.A.D.D.**)
16. Each **Designated Driver Dad** is solely responsible to the Government of Canada, for any and **all taxes**, for any and all funds that are brought into their personal possession while operating under the corporate name, or corporate logo of **Canadian Designated Driver Dads Inc.** (Keep tax receipts of all expenses that you occur, and get receipts for all the donations you receive)
17. The **Canadian Designated Driver Dads Inc.** service is offered strictly by free will donations from each patron. **Canadian Designated Driver Dads Inc.** is **never** in competition with taxi cab services. **Designated Driver Dads** should always direct the patron(s) to use taxi cab drivers first. We strictly just want to give patrons an alternative choice to the temptation of driving drunk from the bars or nightclubs at the end of the night on the weekends.
18. The **Canadian Designated Driver Dads Inc.** is a voluntary service, and is not meant to compete with the taxi cab business. **Canadian Designated Driver Dads Inc.** is simply dads that are willing to help decrease the amount accidents and deaths resulting from people drinking and driving drunk after visiting bars or nightclubs.
19. Each potential **Designated Driver Dad** must agree with & sign off on all these 21 listed items prior to driving any patron(s) vehicle home under the corporate name or corporate logo of **Canadian Designated Driver Dads Inc.** (This sheet is to be printed off, signed at the bottom of this page, and mailed off to the address above.)
20. Each potential **Designated Driver Dad** must provide a current copy of his drivers abstract, and any criminal record information prior to participating, or using the **Canadian Designated Driver Dads Inc.** name or logo. This information is to be sent to the address above for our final approval by **Canadian Designated Driver Dads Inc.**
